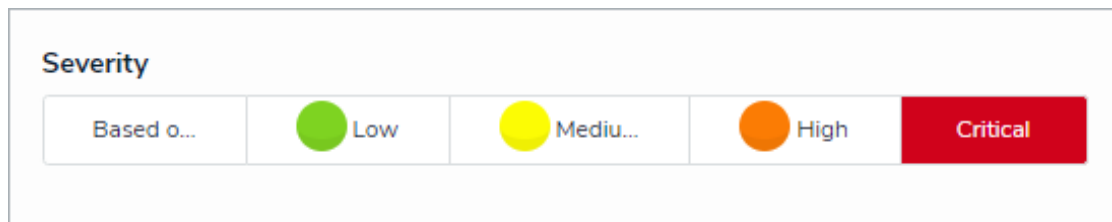


Excluding Archived Incidents from General Access
